ALL-STAR PAPERWORK GUIDELINES FOR RETURNING & NEW ALL-STAR PLAYERS

RETURNING All-Star players are not required to submit new documents, as their records are kept on file by the Managers and the Little League Organization. However, rules are subject to change and if additional paperwork is required for returning players, this will be communicated to parents.

NEW All-Star players are required to prepare and submit the following documents:

- 1. Original birth certificate (this will be returned after the player is approved by the Little League District 36 Administrator).
- 2. "Little League Tournament Player Verification Form" signed by the player's parent/legal guardian AND the PVLL President; form is then submitted to the District 36 Administrator for his signature.
- 3. Select ONE scenario below that applies and complete the document(s) listed under that scenario ONLY. The first two scenarios are the most common.
 - CURRENT RESIDENCE AND CURRENT SCHOOL WITHIN PVLL BOUNDARY:
 - "Little League School Enrollment Form" signed by the player's parent/legal guardian AND your school's principal
 - CURRENT RESIDENCE <u>WITHIN</u> AND CURRENT SCHOOL <u>OUTSIDE</u> PVLL BOUNDARY:
 - Three proof of residency documents listing your full name and address; one document from each of the three document groups listed on the Little League Tournament Player Verification Form"
 - CURRENT RESIDENCE <u>OUTSIDE</u> BUT PRIOR RESIDENCE <u>WITHIN</u> AND CURRENT SCHOOL <u>WITHIN</u> PVLL BOUNDARY
 - "Little League Report of Players Claimed Under Regulation II(d) or II(a) Form" signed by the current PVLL President AND
 - "Little League School Enrollment Form" signed by the player's parent/legal guardian AND your school's principal



- CURRENT AND PRIOR RESIDENCE <u>OUTSIDE</u> AND CURRENT SCHOOL <u>WITHIN</u> PVLL BOUNDARY
 - "Little League Out of Boundary Player Waiver Request Form" signed by player's parent / legal guardian, President of the local Little League Organization in which you reside, and President of PVLL
 - "Little League School Enrollment Form" signed by the player's parent/legal guardian AND your school's principal
- CURRENT RESIDENCE, PRIOR RESIDENCE AND CURRENT SCHOOL <u>OUTSIDE</u> PVLL BOUNDARY
 - "Little League Out of Boundary Player Waiver Request Form" signed by player's parent / legal guardian, President of the local Little League Organization in which you reside, and President of PVLL
 - Three proof of residency documents listing your full name and address; one document from each of the three document groups listed on the Little League Tournament Player Verification Form"
- CURRENT RESIDENCE <u>OUTSIDE</u> BUT <u>SIBLING</u> PREVIOUSLY QUALIFIED USING LITTLE LEAGUE REG II(d) or II(a) FORM" **AND** SCHOOL <u>INSIDE</u> PVLL BOUNDARY
 - "Little League Report of Players Claimed Under Regulation II(d) or II(a) Form" signed by the current PVLL President
 - Copy of sibling's "Little League Report of Players Claimed Under Regulation II(d) or II(a) Form"
 - "Little League School Enrollment Form" signed by the player's parent/legal guardian AND your school's principal
- CURRENT RESIDENCE <u>OUTSIDE</u> BUT <u>SIBLING</u> PREVIOUSLY QUALIFIED USING LITTLE LEAGUE REG II(d) or II(a) FORM" AND SCHOOL <u>OUTSIDE</u> PVLL BOUNDARY
 - "Little League Report of Players Claimed Under Regulation II(d) or II(a) Form" signed by the current PVLL President
 - Copy of sibling's "Little League Report of Players Claimed Under Regulation II(d) or II(a) Form"
 - Three proof of residency documents listing your full name and address; one document from each of the three document groups listed on the Little League Tournament Player Verification Form"
